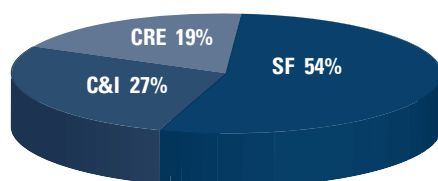

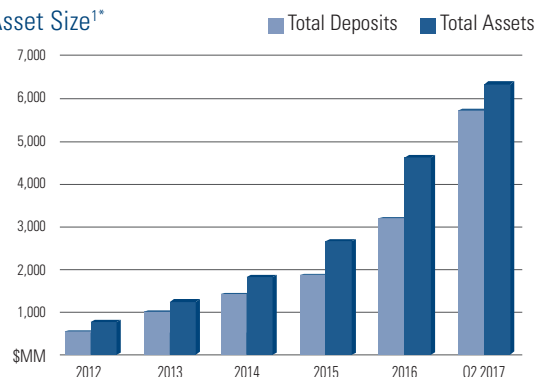
Loan Portfolio (Gross)^{1*}



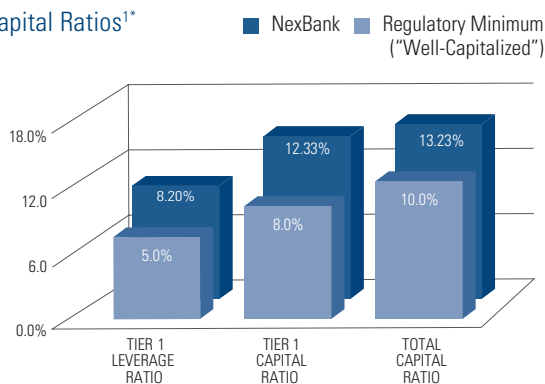

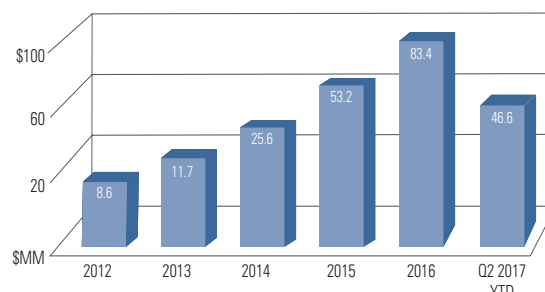
Asset Size^{1*}
